Summer is on the horizon and PHENOM has been hard at work during the last month to help pass an amendment to increase MASSGrant, the state's main need-based financial aid program.

The amendment passed

through the House budgetary process with a total increase of approximately \$2 million, a significant victory for public higher education in a tight fiscal year!

The Senate later considered another amendment to in-

crease MASSGrant by an additional \$5 million but this did not pass. In the coming weeks, it will be considering an addition to the Senate Ways and Means budget to grant MASS-Grant a dedicated earmark in the budget, which it does not currently receive.

Mortgage Assistance Grants

MMI (Money Management International) has created a Preserving Homeownership and Savings Education Strategies (PHASES) program through a \$1 million grant from

HSBC, the provider of the Union Plus Credit Card. PHASES grants can assist qualified homeowners in participating states who are experiencing temporary financial distress and who are past due on one or two mortgage payments. Grants are available to homeowners in 15 states including **Massachusetts**. Call 1-866-490-5361 for more information, any time day or night.

There are times when you may need legal help or you simply have a legal question. Perhaps you've purchased a product that has turned out to be a "lemon", are faced with signing a complicated legal document, or need expert advice on a problem.

Through this exclusive union-

members-only program, you get the legal advice you need at rates you can afford-and most often for free. According to surveys, 75 percent of the matters brought to attorneys through the Legal Service are handled without charge.

This service allows members of participating AFL-CIO unions

to consult an attorney on personal legal matters or to prevent a legal problem. Union-approved lawyers at 1,300 law offices are available.

- A free 30-minute consultation-in person or over the phone

"The Union Plus Legal Service" is designed to meet the needs of working people." said Union Plus President Leslie Tolf. "The program offers free and discounted legal advice-without complications. It helps members avoid the high cost of legal assistance while providing them with service

from an attorney they can trust."

The Union Plus Legal Service does not cover matters involving union-related organizations or officials. Attorneys are not obligated to take a case and may decline if they choose.

Employees at the University of New Hampshire (UNH) are seeking a voice on the job through a historic coordinated effort by two unions-AFSCME and the UAW.

Kelly Hinton, an eight-year financial support specialist, says, "This is great news for all UNH employees. We feel that the two unions working together will be a good fit for the University alongside of the faculty union. Working to-

gether with AFSCME and the UAW means we are united and stronger."

Says Lonnn Sattler, a veterans coordinator who has worked at UNH for 26 years, "This is a terrific opportunity for us to have a real, effective voice on the job. With two great unions working together, we can make UNH a better place to work."

Last year, the state Legislator passed legislation allowing state employees, including those at

UNH, to form unions and bargain with their employers when a majority of workers sign union authorization cards.

AFSCME and UAW agreed to coordinate organizing efforts and support the negotiating teams of all UNH workers who are successful in forming their own local unions and bargaining units. Under the agreement, clerical, technical, skilled trades, and administrative employees and certain

supervisory employees will be eligible to join AFSCME. Service and professional staff, adjunct faculty members and some supervisors will be eligible to become part of the UAW.

Both unions say the partnership will help the workers. Says Bob Madore, director of

UAW Region 9A, "Our goal is to help workers who want to form their own unions. By combining our resources so we can work with AFSCME, we can be even more effective."

Alva Arellano, AFSCME's director of organizing in New England, says, "This is the right approach for UNH work-

ers and for our two unions. We're going to help UNH workers join together so they can have a voice in the decisions that affect their lives and improve the important public services they provide."

AFSCME Local 1067 Scholarships

AFSCME Local 1067 will award (8) \$500 scholarships this year (2008). The applicant must be a member of AFSCME Local 1067, a child of a member of AFSCME Local 1067, or the legal dependent of a member. The applicant must also be a full-time student pursuing a degree at a two-or four-

year College or an accredited institution beyond the high school level. Applications must be postmarked no later than July 1, 2008 and will be awarded at the Local's Executive Board meeting on August 12, 2008. In addition to the application, an essay must be attached. The essay of 250

words or less, written by the applicant, must explain his/her achievements, aspirations, and goals. Please send to:
