GROUP RECLASSIFICATION BILL FOR CAMPUS POLICE

On October 18, 2007, Retirement Bill (House Bill 2551) was heard before the Joint Committee on Public Service. This important bill would move all campus police officers at public higher education institutions from retirement group 1 to retirement group 4. Sergeant Dean Bruno, an AFSCME member from Salem State College, testified on behalf of Local 1067.

Sergeant Bruno has been very involved with this issue. Back in May of 2006 a Blue Ribbon Panel was assigned to the task of reviewing the current State's Retirement Group Classification System and come to a decision on how it could be improved. The panel listened to testimony from several state employees representing differ-

ent job titles. Sergeant Bruno represented all of the state's campus police officers. After hearing all of the testimony the panel made their recommendations.

As of today, all bills regarding group classification must meet nine criteria to be considered for a favorable recommendation by the Joint Committee on Public Service. Sergeant Bruno and Council 93's Jim Durkin did a great job testifying to how our officers meet the nine criteria.

Presently, the bill is still in committee and we will be sending out more information after the holidays.



UNION DUES INCREASE

As of January 1, our union dues will increase. Our dues pay for many things including the salaries and benefits for the staff at Council 93 who work on such things as grievance cases, unfair labor cases, legislative bills, and legislative testi-

Effective January 1, 2008, the monthly union dues for a Full-Timer will be \$33.80 (\$11.50 goes to the International, \$18.60 goes to Council 93, and \$3.70 goes to the Local) and it will be \$25.80 for a Part-timer (\$8.65 to International, \$13.95 to the Council, and \$3.20 to the Local).

Neither the table officers nor the chief stewards at your campuses are paid a stipend or salary for their union activities. Expenses (such as mileage to attend meetings) are reimbursed. At the monthly Executive Board meetings, the Treasurer distributes reports detailing the Local's expenses. These reports are available to any Local member upon request.

Thanks to everyone who responded to the survey and also thanks to those who volunteered to serve on the contract negotiating committee. We had almost 60 members volunteer!

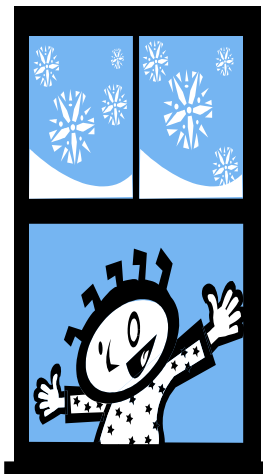
To involve as many people as possible, the committee is comprised of eighteen people: 9 permanent members and 9 alternates. All 18 will participate in the initial
