My Favorite Grievance

My favorite grievance happened back in 1993, when a Campus Police Officer was denied overtime for time spent at the local hospital after he was accidentally punctured with a hypodermic needle. The incident happened at 1:00 p.m. when Campus Police were called to respond to a report that a dormitory student was having an allergic reaction to an injection of Benadryl; and as the needle was handed over to the police, the officer was punctured in his left ring finger. The officer went to the emergency room to have it examined, but by the time he was seen by a physician and informed he was all right, his 7:00 a.m. to 3:00 p.m. shift was done. When the officer put in for overtime it was denied with the notation, “no overtime for treatment.”

When I spoke to the Campus Police Officer about the incident, he stated that while waiting to be treated, he continued to get calls over the radio and directed campus police operations from that site because there were no other sergeants on duty. Further, he mentioned that the President at the College happened to walk by right after the incident happened, and seeing how anxious the officer was after being stuck by the hypodermic needle, advised him to seek medical attention immediately. So I figured, why not contact the President of the College and see if she would back-up the officer’s story about instructing him to seek medical attention. You can imagine both the officer’s and my surprise, when after sending the President of the College a memorandum asking for her assistance, she responded in writing, that “yes, she had directed the officer to go to the hospital to have himself checked out.”

When the President’s memorandum, plus the officer’s statements that he continued his duties while waiting for treatment, were presented at the Step Two hearing, the Director of Human Resources ruled in our favor and granted the overtime request.

This grievance is still remembered at Salem State College, as the time the Union got the President to help them win a grievance!

KNOW YOUR

CONTRACT!!

The winner of the last "Know Your Contract Contest" was Lynn Wilkins from Bunker Hill Community College.

The correct answers were:

Question: Find and correctly site the Article and Section quoted, "The Union shall represent all persons in the bargaining unit without regard to race, color, religious creed, national origin, age, religious affiliation (if any), gender, marital status, sexual orientation or participation in the activities of the Union.

Answer: Article 9: Fair Practices; Section 4.

Question: Find and correctly site the Article and Section quoted, "Where it is currently the practice, at least two employees shall be assigned when working underground, in tunnels, in crawl spaces, in hazardous areas where steam, sewage, electrical, or other systems exist, in trenches with a depth of five or more feet, or when working more than ten feet above the floor or the ground. For other institutions, appropriate precautions (i.e., additional staffing, close supervision, etc.) will be taken to ensure the safety of employees working in these hazardous areas.

Answer: Article 26: Safety Procedures; Section 4.

Question: Find and correctly site the Article and Section quoted, "An employee shall have the right to inspect his/her Official Personnel File during regular business hours upon request and when necessary by appointment, and shall have a right to copy at his/her expense. The Union or a representative thereof, shall have access to an employee's Official Personnel File upon prior written authorization of such employee.

Answer: Article 30: Official Personnel Files; Section 1.

HELPFUL HINTS

Berkshire Community College

Founded in 1960, Berkshire Community College (BCC) was the first of the fifteen colleges, which make up the Massachusetts community college system. For twelve years, the College operated in a former junior high school made available by the city of Pittsfield. There, the number of day students grew from 153 to 1,222. In 1972, the College moved four miles from the center of Pittsfield to a cluster of modern building on a beautiful 180-acre site. Buildings

are named for famous Berkshireites: Susan B. Anthony, Melville, Hawthorne, and Koussevitzky. The property includes a marked nature trail, a pond, extensive playing fields, and an outdoor pool.

In 1984, the College's South County Center opened in Great Barrington. Its purpose is to allow easier access to BCC academic courses for students who live or work in southern Berkshire County, northwest Connecticut, or Columbia County in New York. Last year the College celebrated its 40th anniversary and more than 2,400 students were enrolled in day and evening courses at the main and/or South County Center.

BCC now offers more than 40 associate degrees and certificate programs, including options and concentrations. The office of LifeLong Learning offers a wide range of non-credit courses and workshops both on site and online. The College's Business and Industry Development team offers customized training programs for employees of businesses in Berkshire County at the College or at workplace sites.

BCC employs 57 AFSMCE members. For a campus of 180-acres we have only six, very dedicated, Unit II personnel who handle all the maintenance: i.e. lawn mowing, snow plowing and "related work as required."
